First Generation

1. **Rev. Arnold Scholefield** was born Cal 1787, died on 22 Jul 1836 about age 49, and was buried in Siloam Cemetery, Siloam, Madison, New York, USA.¹

Noted events in his life were:

- He worked as a Methodist Minister from 1810 to 1836.²
- He was enumerated on the US Federal census in 1820 in Plattekill, Ulster, New York.³ Arnold Schofield, 1 male under 10 [George age 1], 1 male 26-45 [Arnold age 33], 3 females under 10, 1 female age 26-45 [Abigail age 32], 1 female 45+.
- He was enumerated on the US Federal census in 1830 in Austerlitz, Columbia, New York.⁴ Arnold Schofield, 1 male 5-10 [George age 8], 1 male 10-15 [Charles age 11], 1 male 40-50 [Arnold age 43], 1 female 1-5 [Harriet age 2], 2 females 5-10 [Charlotte age 5], 1 female 10-15, 1 female 15-20, 1 female 40-50 [Abigail].

- Biography: 1854.⁵
REV. ARNOLD SCHOLEFIELD.
BY HEV. ELBERT OSBORN.

The parents of Mr. Scholefield, it is believed, were natives of the United States; but at the time of his birth they resided in Nova Scotia. In early childhood he returned with his mother to this country. While quite a youth, he became pious, and when about twenty- two years of age, he entered upon the work of the Christian ministry.

On a cold morning in the beginning of the year 1810, a stranger called at my father's house, told us his name, and informed us that the presiding elder of the New York district had sent him to fill a vacancy on that circuit. He preached at my father's house that evening on Isaiah iii, 10; 11. " Say ye to the righteous it shall be well with him" &c. Such was the effect produced on my youthful mind, and such the apparent satisfaction of the hearers generally, that in my childish simplicity I said to my mother, " I guess that man will some time or other become a bishop." That youth was Arnold Scholefield. He labored a few months very acceptably on that circuit (Reading, in Connecticut), under the direction of that excellent but eccentric minister, the Rev. B. Hibbard.

At the ensuing conference, he was received on trial as a traveling preacher, and appointed to Charlotte circuit in Vermont. In 1811, he was sent to Litchfield, Conn., and in 1812-13, to Middletown, in the same state. In 1814, his field of labor was the east end of Long Island, and in 1815-6, in the city of New York. One of the most intelligent laymen of our church, in that city, recently spoke to me with much affection and respect of Mr. Scholefield, of whose pious labors, and amiable character, he seemed to have a lively recollection. In 1817, he was appointed to Albany circuit, and in 1818-19 to Delaware. These circuits were then very large, embracing mountainous regions, which Mr. Scholefield cheerfully explored, in search of blood-bought souls. In 1820-1, he was on the Newburgh circuit, and in 1822-3, the people of Dutchess circuit were blessed with his evangelical labors. Information recently received from an aged, pious and respectable brother confirms the opinion, which I had previously formed, that he was very useful among that people. He was not only successful in leading sinners to God, but also in defending the doctrines of the gospel, and in preserving the lambs of the flock.

In 1824, he was appointed to the charge of the Goshen circuit, in Connecticut. Here I had the privilege of being under his paternal care, as I was the junior preacher on that circuit. It was my second year in the itinerancy, and in Mr. Scholefield I found a father indeed. His manner was affectionate, and his conduct exemplary; his preaching was excellent, and his conversation instructive. I shall never forget my parting with him after we had labored together about eight months. Being sent by my presiding elder to fill a vacancy on another circuit, I called to bid him farewell. While affectionately grasping my hand, he looked upward, and asked me to remember him in my prayers.

In 1825, he was appointed presiding elder of the Rhinebeck district, which then extended from Albany, N. Y., almost to Hartford, Conn., embracing all that part of Massachusetts west of the Connecticut river. He filled the place assigned him, with dignity and usefulness, for three years. Strong was the affection of the preachers under his care towards their presiding elder. Deep was the interest which he manifested in their temporal and spiritual welfare, and in the prosperity of their work. A sermon which he preached at a camp- meeting on Canaan mountain, Litchfield county, Conn., in 1825, is still remembered by some in that region, with great interest. It was on the last evening of the meeting, when the hearts of Christians were- warm with holy fire, and his text was, " Let the inhabitants of the rock sing, let them shout from the tops of the mountains." Isaiah xlii, 11. I trust that some of those who shouted "Glory to God," that evening, are now. with the minister who addressed them, worshipping on Mount Zion and rejoicing before the throne.

At a camp-meeting in 1827, while Mr. Scholcfield was exhorting, two unconverted men were so affected by the force of divine truth that they fell to the earth, the emotions of their souls overcoming their bodily strength. Mr. Scholefield loved, and enjoyed the power of religion.

"At the conference held in New York in 1828, the presiding elder of our district, Rev. A.

Scholefield, was not with us. He was taken sick in May previous, while attending General Conference, in Pittsburgh, far from family and home, and sickness detained him there after the General Conference closed; but a kind brother delegate, Rev. Tobias Spicer, remained with him till he ventured to leave Pittsburgh, and they returned home together. May God grant that these friends may meet in that city where sickness can not come, and where friends never part."* (See Life of Elbert Osborn, page 139.)

* Mr. Scholefield being unable to return home at the close of the General Conference, the question was asked among the New York delegation, "What shall be done in the case of brother Scholefield?" To which Mr. Spicer replied, "I will take that brother home, either dead or alive." He did so. After watching over him for three weeks, he hired a hack, and brought him, by easy stages, to Erie, a distance of some one hundred and fifty miles, from which place they reached home by public conveyances. S. P.

At that conference, he received a supernumerary relation, in which he continued for three years, residing in Austerlitz, Columbia county, N. Y., and laboring in the work of the ministry as his strength permitted. In 1831, he resumed effective work, and was appointed to the charge of the Chatham circuit. Here he rejoiced in seeing the work of God revive. His residence that year was the next door to mine. With great pleasure he would relate to me what God was doing on some parts of the circuit, while he mourned that more good did not result from his labors in other parts. During this year he had the unspeakable pleasure of witnessing the conversion of his eldest daughter, at a camp-meeting held at Canaan, Columbia county, N. Y. After a pious life of some years, she was called from earth to her heavenly home. At the same meeting, he preached, by request of his brethren, a sermon on a controverted subject. The discourse brought light to the understanding, and warmth to the heart. During the meeting, several from his circuit were made partakers of pardoning mercy. Some, who are now prominent ministers in the different conferences, were then young preachers, sitting under his instruction with delight, and they doubtless still remember the gracious season.

In 1832* he was appointed presiding elder of the Troy district. Before the year expired, a paralytic stroke disabled him from regular service in that work which he loved so well. While in a superannuated relation, he remarked in a letter to the writer: "If health and strength permitted, how gladly would I again take the roughest circuit I ever traveled, and point sinners to the Lamb of God."

* The Troy Conference was organized in 1832, by a division of the New York Conference, and Mr. Scholefield became a member of the former. S. P.

"Shortly after the session of the Troy Conference, in 1836, Mr. Scholefield was returning with his wife, from visiting his friends east of Albany: they had occasion to ride in the evening, in order to reach a public house. When within about two miles of Spraker's tavern, in the town of Palatine, he dropped his whip, began to slap his right hand on his thigh, and to stamp his foot. He attempted to speak, but could scarcely articulate a word. Mrs. Scholefield took the reins, and succeeded in getting him to the tavern. He never uttered another sentence; but after lingering three days and a half, he expired." (Gen. Minutes, v. 2, p. 495.)

Mr. Scholefield was an affectionate husband and father, a kind neighbor and an ardent lover of his country. The unconverted highly respected him as a worthy man and citizen. The friends of Jesus were very dear to him, especially his brethren in the ministry. He delighted greatly in their society. Well do I recollect spending a night with him, in company with another preacher, on our return from a camp-meeting. The glorious season which we enjoyed that evening in a little family prayer meeting, is still fresh in my memory, after the lapse of twenty-three years.

"And if our fellowship below,
In Jesus be so sweet,
What heights of rapture shall we know,
When round his throne we meet!"

Mr. Scholefield was a man of firmness and decision of character. Although abundant in kindness, he was ready to defend the truth. Perhaps few men were more capable of meeting and repelling the champions of error than was Arnold Scholefield, and few would do it with such Christian meekness.

He had a heart to sympathize with the afflicted. His fervent prayers for, and with my family and

myself, when a beloved little one lay on the bed of death, indicated the warmth of his brotherly love, and the depth of his Christian sympathy. His strength of mind, the extent of his general information, and his unwavering attachment to the cause of God, and to "Christianity in earnest," led his brethren cheerfully and repeatedly to elect him to the responsible post of a delegate to the General Conference.

His plainness of dress, his condescension to inferiors, and his willingness to labor, when necessary, with his hands, all tended to satisfy the observer that he possessed that charity which "vaunteth not itself, is not puffed up." Those who are now the elder ministers of the New York, Troy and New York East conferences, must have a vivid recollection of the bland appearance of our departed brother, as they used to meet him at the annual gatherings of the original New York Conference, when he always had a kind word for the youngest and weakest of his brethren.

Among those whom we believe God gave him as seals to his ministry, was one, at least, who became a useful minister of the Lord Jesus. Many of those who were persuaded by Mr. Scholefield to come to Christ, and with whom he offered strong cries to God for their deliverance from guilt, are now, we believe, uniting with him in ascribing praises to God and the Lamb. May all who loved him on earth, dwell with him in the regions of everlasting glory.

To what Mr. Osborn has said, a few words may be added. Arnold Scholefield was a man of no ordinary character.

He was a lovely man. Possessed of an even temper, gentlemanly and agreeable in all his intercourse, his conversation was well calculated to win the affections, while it ministered grace to the hearers. The more substantial part of his church, especially, appreciated and esteemed him.

He was a strong man. Not imaginative, not flowery, but possessed of a vigorous intellect, a clear head, and a sound judgment.

He was decidedly an able preacher. There was a peculiar richness and pleasing variety in his sermons. They were thoroughly studied, well arranged, and full of evangelical sentiment. There was no mouthing, no effort at display in his preaching; he aimed at results, and by the blessing of God he reached them. His voice, though strong, was clear, and musical. There was more of Paul, however, than of Apollos in his preaching. Argument was his forte; and in defending the great principles of Christianity he was a master-workman. Some of his doctrinal sermons are vividly remembered after the lapse of a quarter of a century. A sermon preached by him at a camp-meeting at Sandlake in 1825, lives in the memory of his hearers. His text was Ezekiel xxxiii, 13-6: "When I shall say to the righteous, that he shall surely live; if he trust to his own righteousness and commit iniquity, all his righteousness shall not be remembered; but for his iniquity that he hath committed he shall die for it. Again when I say unto the wicked, &c." His propositions were: First. The wicked man may become good and be saved. Second. The righteous man may become wicked and be lost.

These propositions were sustained by an array of pertinent scriptural arguments, with a clearness and power that was overwhelming. Though he often dealt heavy blows at the dogmas of Calvinism, he ever kept in view the motto adopted by the sainted Fletcher, "Let brotherly love continue."

Such was the meek, talented, laborious Scholefield. If we may but have a succession of such men in the ministry, truth and righteousness will triumph through the land.

- Biography: 1889.⁶
Scholefield, Arnold, a Methodist Episcopal minister, was born in Nova Scotia; united himself with the Methodist Episcopal Church while quite a youth; was admitted on trial in May, 1810, from which time he travelled and labored in the work of the ministry with great acceptance and usefulness until his health failed in 1828. In 1832 he was again reported effective, and appointed to travel on Troy district, but had not travelled long before he was gain rendered ineffective by paralysis, and died in 1837. He was an able and laborious minister of the Gospel, and very ardent in his religious feelings. His sermons were characterized by a peculiar richness and pleasing variety, and were unusually delivered with much pathos. See Minutes of Conferences, ii, 495; Bangs, Hist. of the M. E. Church, iii, 252.

Arnold married **Abigail Burnham**, daughter of **George Burnham** and **Nancy Bigelow**, on 1 Apr 1814.⁷ Abigail was born on 8 Jan 1788 in Connecticut, USA⁷ and died on 20 Dec 1868⁷ at age 80.

- Her funeral was held on 22 Dec 1868 in Whitestown, Oneida, New York.¹¹ The event was reported in the Utica Morning Herald:
FUNERAL OF MRS. SCHOLEFIELD. -- The funeral of Mrs. ABIGAL SCHOLEFIELD, of Whitestown, was attended yesterday from the residence of her son, Major C. M. SCHOLEFIELD, at 2 p.m. Rev. J. F. CRAWFORD conducted the services, which consisted of singing, reading the Scripture and prayers, with an appropriate and impressive address in which he adverted to several interesting incidents in the life of Mrs. SCHOLEFIELD, and set for her peculiarly bright and attractive example as challenging the emulation of her descendants and of all her surviving friends. She departed at the ripe old age of 81, after having acted well her part, and retained her faculties to the last. She performed life's duties with cheerfulness, bore its trials with patience and resignation, and has left an imperishable memorial in the hearts of her descendants and other friends. As she approached the spirit world, she seemed to hear voices cheering her on and hastening her forward, and went not unwillingly, to join we doubt not the great assembly of the departed good.
- Her obituary was published in the Utica Morning Herald and Gazette on 22 Dec 1868 in Utica, Oneida, New York, USA.¹²

Major Scholefield was a more than ordinarily acceptable public speaker and was much in demand as a temperance lecturer. Mrs. Scholefield will be remembered as a charming and attractive woman who did much to make the home a social center and who was held in high esteem by all who knew her. Major Scholefield died many years ago.

Mrs. Helen M. Scholefield, his widow, died in New York city Saturday in her 79th year. She was born in Amsterdam, being descended from the earliest Dutch settlers of the Mohawk valley. In 1859, she married Mr. Scholefield. During the Civil war, she lived in Washington, her husband and brother being officers in the army, and each day ministered to the sick and wounded in the hospital at a time when there were no trained nurses and very little knowledge of anesthetics. At the close of the war, they returned to Yorkville, but spent much time in Albany, as Major Scholefield was a member of the legislature and a prominent lawyer, editor and public speaker.

Upon the death of her husband, the family moved to Utica and Mrs. Scholefield opened a kindergarten, being a pioneer in that form of education, now a part of the public school system. She was a member of Westminster church and active in its work as well as the literary and social life of Utica.

In recent years she had made her home with her daughters, Mrs. Mae Edwards, of Nutley, N. FLEEING FROM THE APACHES.

Geo. W. P. Scholefield Driven by the Indians From His Ranch in Arizona.

Recently George W. P. Scholefield, who will be remembered as a former student at the Amsterdam Academy, his wife and children, and his mother, Mrs. Helen M. Scholefield, Sister of Capt. A. H. DeGraff, who went out to visit him a few months ago, were driven from his ranch in Arizona Territory by an uprising of the Apache Indians. Capt. DeGraff has just received a letter from Mrs. Scholefield giving full particulars, from which the following is taken:

George went with some friends into Tucson to locate some property. As that time everything was safe. He went on Monday, and left me with his partner, G. Denmon, in charge of the ranch. On Tuesday morning at day break a Mexican came riding up to the door, and said: "The Apaches are in the mountains, and I was sent here to tell you to run." We tried to hire him to stay and help us, but he said no, he must warn others further off. There we were, up in the mountains with one man that knew nothing of the Indians. He was a good shot, however, and would stand by us. Our first impulse was to run, but as we had but one little mule in the corral, and all the other horses were out somewhere in the mountains, and as we did not know which way to turn, we changed our minds and began to prepare to fight. The house is wood, and in no spot bullet-proof. The Indians never take any risks. If you see them and are prepared, you usually have the best of it. But to see them here is difficult, as mountain peaks rise one above the other as far as the eye can reach, not only the Santa Ritas, but a dozen different ranches. We had plenty of guns of different kinds, and could fire over forty shots without reloading. Clara (her son's wife) and I took charge of watching the front of the house, and Mr. Denmon the back. We put the guns all in order, learned how to load and fire, took up some boards in the kitchen floor and put in blankets for baby and Armour, took mattresses and trunks and fixed things as well we could. At nine o'clock Mr. Richardson sent a man. He had ridden twenty miles. Mr. Richardson wrote to George to tell him that they had been attacked the night before, but with several Mexicans and by the protection of their adobe house they had driven the Indians off. He said that there were three bands, that of Geronimo and two other bands of Crook's, old scouts that Miles had discharged. (You know General Crook employed ninety Apache scouts who really belonged to Geronimo's band.) He told George to get in some small canyon and in the night get to the Empire. We knew if the Indians made a strike for the Whitestone mountains, they must pass through this, the St. Helena canyon, or one other. We also know that if Mr. Vail, of the Empire, was at home he would send us help to get to his ranch, but he was in California and his superintendent, Phil. Moore, was with George. We wrote to Mr. Richardson our condition and asked him to send help as soon as he could, but we were not sure the man would go back. Well, I cannot tell you what an anxious time we had. The dogs helped us keep guard. Sometimes a thousand head of cattle come to the troughs to drink, but during that day and the next not one appeared, only now and then a used up horse of the Indians. Just at break of day George appeared with Phil. Moore and a team from the Empire, and another friend on horseback. I know that George would get news in Tucson, and come as soon as he could. He told us to take ten minutes to put on string shoes, tie something over our heads, and take just a change for the children. He put some blankets in the backboard, and then let out everything, the chickens and ducks, and little calves of the milch cows, and the pet birds. The Indians had cut the water pipes in the mountains the day before. He said we might get to the Empire, and we might have to hide somewhere, so we put in some provisions. Clara and I were put in the bottom of the wagon. Phil Moore driving, George and Mr. Denmon going ahead to break ambushes, and Ned Vail behind. The Empire ranch was seventeen miles off, and we had to cross three ranges of mountains I never shall forget that ride. It was first a rush and then hide, until they rode ahead and came back for us. I can assure you I was glad to drive within the high adobe walls of the Empire ranch. It was many hours after that before I could ask George about his journey. He told me he appealed to General Miles to get an order for an extra train, and when they got to Pontons, where

they had left their horses, they could find but three. Then they had an awful time to get through. They were obliged to try several different ways and to go to the Empire for fresh horses and the team for us. They had been thirty-two hours in the saddle. This is the largest ranch in the territory, and has 40,000 head of cattle, and 5,000 head of horses. The St. Helena belonged to the proprietor until George and Mr. Denmon bought it. General Miles is sending troops into the country now very fast. We do not think the Indians have burned our house, as the flames would show their position. We are only eighteen miles from Mexico, and they dart back and forth. It is dark and we are allowed no lights. The men are on guard day and night. We have every care. The Mexican starts at daybreak for the mail. We hope to get back to the ranch very soon.

Mrs. Scholefield's address is Greaterville, Pima county, Arizona, St. Helena ranch. It is to be hoped that she and her son's family may meet with no further anxieties and dangers, and that when they return to the ranch they may find it unharmed.

GEORGE P. SCHOLEFIELD. Now extensively engaged in the cattle industry in the vicinity of Tucson, Mr. Scholefield was born in Utica, N. Y., May 23, 1860. Of interesting ancestry, the best remembered of the family is the paternal great-grandfather, Sir William Scholefield, who was born in England, as was his son Arnold, the paternal grandfather. Arnold Scholefield was a dissenter from the Church of England, and in consequence was disinherited by his father, who cherished the old-time intolerance of all save his own method of worship. In search of broader and more liberal fields in which to preach the gospel as propounded by the Methodist Church, Rev. Arnold Scholefield came to America, and ministered to the spiritual necessities of his locality in New York state until his death.

The father of George P. Scholefield, Charles M., was born in Cooperstown, N. Y., graduated from Union College, and in after years became one of the prominent attorneys of the state. He spent the greater part of his active life in Utica, N. Y., and was a law partner of Roscoe Conkling. During the Civil war he enlisted as second lieutenant of a company of New York regulars, and was finally raised to the rank of major. He was affiliated with the Republican party, and served for three terms as assemblyman, and for one term as state senator. He arose to a high place in his profession, and was, with Chauncey M. Depew, attorney for the Vanderbilt railroads. He was also a prominent Mason, and identified with the most advanced undertakings of the city in which he lived. Mr. Scholefield lived to be fifty-two years of age. His wife was, before her marriage, Helen M. De Graff, who was born in Amsterdam, N. Y., and a daughter of Emanuel De Graff, a native of Holland, and a farmer in the Mohawk valley. Mrs. Scholefield, who now lives in New York, is the mother of four children, of which George P. is the oldest and the only son.

In Utica, N. Y., George P. Scholefield received his early home training, and when eleven years of age became a page in the New York state senate, and after a service of two years, became a messenger in the New York assembly. He was later a clerk in the assembly for three years, and in the meantime had been diligently attending the public schools and later was graduated from high-school at Utica. In 1879 he became associated with the territory of Arizona, as auditor for the Centennial Mining Company, and after the expiration of a year was connected with the Old Dominion Copper Mining Company for a period covering four years. Incidentally he had become interested in the cattle business, first on the Coon creek, until the Tonto basin feud, and in 1885 he established a ranch in Pima county where, until the present time he has engaged in raising cattle and horses. The ranch is forty miles southeast from Tucson, in the Santa Rita mountains, and is one of the most successfully conducted affairs of the kind in the county.

It is doubtful if any in the territory are better informed on all phases of the cattle business than is Mr. Scholefield. In this connection he had received extended appreciation from his fellow cattlemen even before locating in Tucson. From the passing of the law requiring an inspector, he filled this important position from 1894 until 1898, at which time he located in Tucson. He was then reappointed inspector of district No. 3, and in 1899 started a live-stock commission business, real estate, mines, etc. He has built a residence in the city. At different times he has been associated with various organizations in the city and county, and was deputy collector of customs for two years. He was also secretary of the South Arizona Stockmen's Association, which is now discontinued. Fraternally he is associated with the Benevolent Protective Order of Elks. In politics a Republican, he is an ex-member of the county and territorial central committees, and has held several local offices within the gift of the people.

In Globe, Ariz., Mr. Scholefield married Clara A. Moore, a native of San Bernardino, Cal., and a daughter of Capt. James Moore. Captain Moore was born in England, where he became in time a sea captain. Upon immigrating to America he still followed the fortunes of the deep until 1849, when he

Smoking in bed apparently cost a Tucson man his life today, police and fire department officials said.

They said A. Major Brodie was trying to get to a door in a bedroom when he apparently was overcome by flames and smoke in his home at 929 N. Hoff Ave. about 5 am.

Damage to the two-bedroom stucco and wood fram home was estimated at \$4,500. Officials said that the area around the man's bed was the most severely blackened. leading to the smoking theory.

The victim, belived to be 58, was alone in the house.

Brodie, who formerly worked for the State Highway Department, was the son of the late Mrs. Helen Scholfield Brodie, who was with the county assessor's office for 34 years.

Simon, son of Daniel, born April 6th, 1753, married December 6th, 1779, first, Annatie, daughter of Simon Schermerhorn. She died September 21st, 1783, leaving one child, Gezina, who died young. He secondly married, April 12th, 1787, Jannete, daughter of Harmanus Bradt. Their children were:

Daniel, born August 12th, 1788, who married a daughter of the old surveyor, Josias Swart; also a son named **Harmanus, born January 8th, 1791**; also a daughter named Annatje, born August 23d, 1794, and now the widow of Alexander Van Eps, and residing in Schenectady.

Simon DeGraff's first wife, Jannete, was a sister of Maus and John Schermerhorn, deceased, aged citizens so long and favorably known in this community.

Columnist Has Personal Interest In Amsterdam Widow Susan Road

A bit of Amsterdam area history was included in yesterday's issue of the Yonkers Herald Statesman where the column, "First Person Singular," attracts attention with the headline: "There's a Widow Susan Road Upstate Named for My Mother's Grandmother."

Identifying himself with the DeGraff family, Columnist George S. McMillan, begins the reflections with "My mother's mother was a DeGraff."

"The family originally came from Holland. Cornelius DeGraff was burgomaster of Amsterdam in 1656. His son, Claas, came to America about 1679 and settled near what is now Amsterdam, N.Y. When I was a boy, there was a station on the New York Central there named DeGraff.

"In any event, my mother, as a little girl, used to spend many of her summers with her beloved grandmother, Susan DeGraff, on her farm on the outskirts of Amsterdam.

"As she told it to me, her grandmother was a pretty wonderful person. Her husband died a fairly young man, and she ran the farm as women did in those days before luncheon bridges and cocktail parties. She was known far and wide in that section of the country as 'the Widow Susan.'

"Years later, after my brother, my sister and I came along, our family would periodically visit Amsterdam to call on our cousins and second cousins named DeGraff.

"Sometimes we would drive up a country road east of the city, and Mother would point out to us the Widow Susan's farm, which had long since passed out of the family's hands.

"But today, if you will drive slowly and watch closely as you approach Amsterdam from the east on Route 5, you will see a road, now paved with many, many houses replacing the open fields of long ago. And, if you look sharply, you will see a streetmarker at the intersection which reads, 'Widow Susan Rd.'

"I don't suppose any traveler passing it- or, indeed, many of those who live on it- know who the Widow Susan was, but I do, and I'm glad her memory is marked, at least to that extent," Columnist McMillan concludes.

Mrs. Scholefield, whose maiden name was Miss Helen M. DeGraff was a sister of the late Capt. Alonzo H. DeGraff of Amsterdam. Her girlhood days were passed in this city but for many years she has been a resident of New York. She married the late Major Charles Scholefield. The burial was at Chatham, N. Y., today.

The Utica Press says: There are very many people still residing in this city and our ancient suburb who remember Major Charles M. Scholefield and wife who lived many years ago at Yorkville. They were very prominent and popular people in their time and had a very large circle of friends and acquaintances.

Major Scholefield was a more than ordinarily acceptable public speaker and was much in demand as a temperance lecturer. Mrs. Scholefield will be remembered as a charming and attractive woman who did much to make the home a social center and who was held in high esteem by all who knew her. Major Scholefield died many years ago.

Mrs. Helen M. Scholefield, his widow, died in New York city Saturday in her 79th year. She was born in Amsterdam, being descended from the earliest Dutch settlers of the Mohawk valley. In 1859, she married Mr. Scholefield. During the Civil war, she lived in Washington, her husband and brother being officers in the army, and each day ministered to the sick and wounded in the hospital at a time when there were no trained nurses and very little knowledge of anesthetics. At the close of the war, they returned to Yorkville, but spent much time in Albany, as Major Scholefield was a member of the legislature and a prominent lawyer, editor and public speaker.

Upon the death of her husband, the family moved to Utica and Mrs. Scholefield opened a kindergarten, being a pioneer in that form of education, now a part of the public school system. She was a member of Westminster church and active in its work as well as the literary and social life of Utica.

In recent years she had made her home with her daughters, Mrs. Mae Edwards, of Nutley, N. J., until her death three years ago; with Mrs. Florence DeGraff in New York, where she died, and with Mrs. Virginia S. McMillan, during the summers at her country home, Spencertown. DeGraff, Alonzo H., Amsterdam, was born in the town of Amsterdam on the 12th of December, 1846, and was educated in the public schools and Amsterdam Academy. He enlisted twice, first on the 1st of June, 1862, in Company C, 25th N. Y. S. N. Guard, and then re-enlisted June 17, 1863, in Company M, 14th N. Y. Heavy Artillery, and was promoted to first sergeant, then to second lieutenant, and also to first lieutenant, and was discharged as captain of the same company in September, 1865. He is by profession a civil engineer and has had charge of the construction of several important railways, and is now superintendent of the Amsterdam water works. After three months' service as a private at Suffolk, Va., he re-enlisted at Utica in the Fourteenth New York Heavy Artillery, with which he remained until September, 1865. He was promoted in succession to sergeant, second lieutenant, first lieutenant, and then captain. He participated in the battles of the Wilderness, Spottsylvania Court House, Cold Harbor, Bethesda Church, North Ann River and Petersburg. On June 17, 1864, he was wounded in the right hip in a charge on the enemy's works in front of Petersburg. Captain DeGraff was one of the leading spirits of post E. S. Young, G. A. R. A. H. DeGraff Camp, Sons of Veterans, was named after him. In 1875 Captain DeGraff married Miss Mary M. Smith of Fish House. A man of strict integrity, his death brought deep grief to a large circle of friends.

In the matter of the petition of Catharine McGowan.

In September, 1856, Judge Whiting issued a writ of habeas corpus directing D. Tilden Brown, esq., Superintendent and Physician of the Bloomingdale Lunatic Asylum, to produce Ann Moore, the wife of Archibald Dunlap Moore, and sister of the relator. The petition set forth that Mrs. Moore was not insane, but that she was illegally deprived of her liberty.

The writ was returnable Oct. 10 of that year. The return set forth that the lady was placed in the Asylum on the certificate two physicians that she was of unsound mind.

The return was traversed and the matter referred to Lewis H.[?] Reed, esq., who reported about a month ago that Mrs. Moore was insane. On Monday a motion was made to discharge her on the ground that she is of sound mind. She has been confined for twelve years.

FLEEING FROM THE APACHES.

Geo. W. P. Scholefield Driven by the Indians From His Ranch in Arizona.

Recently George W. P. Scholefield, who will be remembered as a former student at the Amsterdam Academy, his wife and children, and his mother, Mrs. Helen M. Scholefield, Sister of Capt. A. H. DeGraff, who went out to visit him a few months ago, were driven from his ranch in Arizona Territory by an uprising of the Apache Indians. Capt. DeGraff has just received a letter from Mrs. Scholefield giving full particulars, from which the following is taken:

George went with some friends into Tucson to locate some property. As that time everything was safe. He went on Monday, and left me with his partner, G. Denmon, in charge of the ranch. On Tuesday morning at day break a Mexican came riding up to the door, and said: "The Apaches are in the mountains, and I was sent here to tell you to run." We tried to hire him to stay and help us, but he said no, he must warn others further off. There we were, up in the mountains with one man that knew nothing of the Indians. He was a good shot, however, and would stand by us. Our first impulse was to run, but as we had but one little mule in the corral, and all the other horses were out somewhere in the mountains, and as we did not know which way to turn, we changed our minds and began to prepare to fight. The house is wood, and in no spot bullet-proof. The Indians never take any risks. If you see them and are prepared, you usually have the best of it. But to see them here is difficult, as mountain peaks rise one above the other as far as the eye can reach, not only the Santa Ritas, but a dozen different ranches. We had plenty of guns of different kinds, and could fire over forty shots without reloading. Clara (her son's wife) and I took charge of watching the front of the house, and Mr. Denmon the back. We put the guns all in order, learned how to load and fire, took up some boards in the kitchen floor and put in blankets for baby and Armour, took mattresses and trunks and fixed things as well we could. At nine o'clock Mr. Richardson sent a man. He had ridden twenty miles. Mr. Richardson wrote to George to tell him that they had been attacked the night before, but with several Mexicans and by the protection of their adobe house they had driven the Indians off. He said that there were three bands, that of Geronimo and two other bands of Crook's, old scouts that Miles had discharged. (You know General Crook employed ninety Apache scouts who really belonged to Geronimo's band.) He told George to get in some small canyon and in the night get to the Empire. We knew if the Indians made a strike for the Whitestone mountains, they must pass through this, the St. Helena canyon, or one other. We also know that if Mr. Vail, of the Empire, was at home he would send us help to get to his ranch, but he was in California and his superintendent, Phil. Moore, was with George. We wrote to Mr. Richardson our condition and asked him to send help as soon as he could, but were not sure the man would go back. Well, I cannot tell you what an anxious time we had. The dogs helped us keep guard. Sometimes a thousand head of cattle come to the troughs to drink, but during that day and the next not one appeared, only now and then a used up horse of the Indians. Just at break of day George appeared with Phil. Moore and a team from the Empire, and another friend on horseback. I know that George would get news in Tucson, and come as soon as he could. He told us to take ten minutes to put on string shoes, tie something over our heads, and take just a change for the children. He put some blankets in the backboard, and then let out everything, the chickens and ducks, and little calves of the milch cows, and the pet birds. The Indians had cut the water pipes in the mountains the day before. He said we might get to the Empire, and we might have to hide somewhere, so we put in some provisions. Clara and I were put in the bottom of the wagon. Phil Moore driving, George and Mr. Denmon going ahead to break ambushes, and Ned Vail behind. The Empire ranch was seventeen miles off, and we had to cross three ranges of mountains I never shall forget that ride. It was first a rush and then hide, until they rode ahead and came back for us. I can assure you I was glad to drive within the high adobe walls of the Empire ranch. It was many hours after that before I could ask George about his journey. He told me he appealed to General Miles to get an order for an extra train, and when they got to Pontons, where they had left their horses, they could find but three. Then they had an awful time to get through. They were obliged to try several different ways and to go to the Empire for fresh horses and the team for us.

They had been thirty-two hours in the saddle. This is the largest ranch in the territory, and has 40,000 head of cattle, and 5,000 head of horses. The St. Helena belonged to the proprietor until George and Mr. Denmon bought it. General Miles is sending troops into the country now very fast. We do not think the Indians have burned our house, as the flames would show their position. We are only eighteen miles from Mexico, and they dart back and forth. It is dark and we are allowed no lights. The men are on guard day and night. We have every care. The Mexican starts at daybreak for the mail. We hope to get back to the ranch very soon.

Mrs. Scholefield's address is Greaterville, Pima county, Arizona, St. Helena ranch. It is to be hoped that she and her son's family may meet with no further anxieties and dangers, and that when they return to the ranch they may find it unharmed.

GEORGE P. SCHOLEFIELD. Now extensively engaged in the cattle industry in the vicinity of Tucson, Mr. Scholefield was born in Utica, N. Y., May 23, 1860. Of interesting ancestry, the best remembered of the family is the paternal great-grandfather, Sir William Scholefield, who was born in England, as was his son Arnold, the paternal grandfather. Arnold Scholefield was a dissenter from the Church of England, and in consequence was disinherited by his father, who cherished the old-time intolerance of all save his own method of worship. In search of broader and more liberal fields in which to preach the gospel as propounded by the Methodist Church, Rev. Arnold Scholefield came to America, and ministered to the spiritual necessities of his locality in New York state until his death.

The father of George P. Scholefield, Charles M., was born in Cooperstown, N. Y., graduated from Union College, and in after years became one of the prominent attorneys of the state. He spent the greater part of his active life in Utica, N. Y., and was a law partner of Roscoe Conkling. During the Civil war he enlisted as second lieutenant of a company of New York regulars, and was finally raised to the rank of major. He was affiliated with the Republican party, and served for three terms as assemblyman, and for one term as state senator. He arose to a high place in his profession, and was, with Chauncey M. Depew, attorney for the Vanderbilt railroads. He was also a prominent Mason, and identified with the most advanced undertakings of the city in which he lived. Mr. Scholefield lived to be fifty-two years of age. His wife was, before her marriage, Helen M. De Graff, who was born in Amsterdam, N. Y., and a daughter of Emanuel De Graff, a native of Holland, and a farmer in the Mohawk valley. Mrs. Scholefield, who now lives in New York, is the mother of four children, of which George P. is the oldest and the only son.

In Utica, N. Y., George P. Scholefield received his early home training, and when eleven years of age became a page in the New York state senate, and after a service of two years, became a messenger in the New York assembly. He was later a clerk in the assembly for three years, and in the meantime had been diligently attending the public schools and later was graduated from high-school at Utica. In 1879 he became associated with the territory of Arizona, as auditor for the Centennial Mining Company, and after the expiration of a year was connected with the Old Dominion Copper Mining Company for a period covering four years. Incidentally he had become interested in the cattle business, first on the Coon creek, until the Tonto basin feud, and in 1885 he established a ranch in Pima county where, until the present time he has engaged in raising cattle and horses. The ranch is forty miles southeast from Tucson, in the Santa Rita mountains, and is one of the most successfully conducted affairs of the kind in the county.

It is doubtful if any in the territory are better informed on all phases of the cattle business than is Mr. Scholefield. In this connection he had received extended appreciation from his fellow cattlemen even before locating in Tucson. From the passing of the law requiring an inspector, he filled this important position from 1894 until 1898, at which time he located in Tucson. He was then reappointed inspector of district No. 3, and in 1899 started a live-stock commission business, real estate, mines, etc. He has built a residence in the city. At different times he has been associated with various organizations in the city and county, and was deputy collector of customs for two years. He was also secretary of the South Arizona Stockmen's Association, which is now discontinued. Fraternally he is associated with the Benevolent Protective Order of Elks. In politics a Republican, he is an ex-member of the county and territorial central committees, and has held several local offices within the gift of the people.

In Globe, Ariz., Mr. Scholefield married Clara A. Moore, a native of San Bernardino, Cal., and a daughter of Capt. James Moore. Captain Moore was born in England, where he became in time a sea captain. Upon immigrating to America he still followed the fortunes of the deep until 1849, when he left behind him the roving life upon the main, and settled down to the mining of gold in California. When the fever had worn away he became interested in the stage business and ran a daily overland stage coach with six horses, between Yuma and Tucson. When the advent of the railroad diminished the receipts of the time-honored and now almost obsolete stage coach, he turned his attention to mining in the Globe district, where he eventually died. His wife is still living at Globe. To Mr. and
